Solicitor Weitzmann will look at the Open Space deeds to see if there are specific restrictions, if not – unless there are houses within the Safety Zone, the property can probably be hunted on.

### **PA State Police:**

PA State Police Officer handed out Activity Report for October 2017 in Jackson Township – there was a total of 142 incidents, the highest being Collisions Investigations – the lowest being Assault Investigations.
